

## 2021 COLLEGE COLORS DAY WEEKLY SWEEPSTAKES

### OFFICIAL RULES

**NO PURCHASE IS NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**If you enter this Sweepstakes via your mobile device, message and data rates may apply.**

#### 1. ELIGIBILITY:

A. The 2021 College Colors Day Weekly Sweepstakes (the “Sweepstakes”) is open to: (i) legal residents of the 48 contiguous United States and the District of Columbia (excluding residents of Alaska and Hawaii), who are age eighteen (18) years or older (or at least the age of majority in their state of residence if greater than 18) at the time of entry. Employees, contractors, members, directors, and officers of Collegiate Licensing Company, LLC (“Sponsor”), its parent, subsidiaries, divisions, trustees, franchisees, participating vendors, sponsors, advertising and promotion agencies, successor entities, and affiliated entities (collectively, including Sponsor, the “Sweepstakes Entities”), and the immediate family members (spouse, parent, child, sibling, and any of their respective spouses) and/or household members of any such person (whether or not related) are not eligible to win.

B. The Sweepstakes is governed by U.S. law and is subject to all applicable federal, state, and local laws and regulations. #### 2. SWEEPSTAKES PERIOD/HOW TO ENTER:

A. The Sweepstakes Period consists of one (1) grand prize entry pool and five (5) separate weekly entry periods (each an “Entry Period” or “Weekly Entry Period”) as set forth below.

All entries must be received before the Entry Period’s end time/date to be valid for such Entry Period. Non-winning entries from one Entry Period will **NOT** roll into subsequent Entry Periods, if any.

B. How to Enter: To enter, during the Sweepstakes Period, eligible entrants must visit the website located at [www.collegecolorsday.com](http://www.collegecolorsday.com) (the "Sweepstakes Website") and follow the instructions to complete and submit the online form, including entrant's name, address, telephone number, email address, age, and/or any other information requested on the form. Each valid entry will earn the entrant one (1) entry into the corresponding Entry Period and one (1) entry into the grand prize entry pool.

*Limit* one (1) entry per person/email address per day during the Sweepstakes Period. For purposes of this Sweepstakes, "day" means each calendar day (starting at 12:00:00 am ET and ending at 11:59:59 pm ET on the corresponding day). Therefore, there is a limit of seven (7) entries per person/email address during each Entry Period and a limit of 35 entries into the grand prize entry pool per person/email address during the Sweepstakes Period.

Individuals who do not follow all of the instructions, provide the required information, timely submit the form as indicated herein, and/or abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries generated by script, macro, or other automated means will be void. Any entrant who attempts to enter with multiple e-mail addresses, under multiple identities, or uses any device or artifice to register multiple times will be disqualified and forfeits any and all prizes won, in Sponsor's sole discretion. Multiple entrants are not permitted to share the same e-mail address. Should multiple users of the same e-mail account enter the Sweepstakes and a dispute thereafter arise regarding the identity of the entrant, the authorized account holder of said e-mail account at the time of entry will be considered the entrant. "Authorized Account Holder" is defined as the natural person who is assigned an e-mail address by an Internet access provider, on-line service provider or other organization which is responsible for assigning e-mail addresses or the domain associated with the submitted e-mail address. Potential winner may be required to show proof of being the Authorized Account Holder.

### 3. DRAWING, ODDS, AND HOW TO WIN:

- On or about the date listed in the chart above (as “Entry Period’s Approximate Drawing Date”), the Sponsor will randomly select one (1) potential winner for each Entry Period from among all eligible entries received for such Entry Period. Odds of winning an Entry Period prize depend on the number of eligible entries received for such Entry Period. **Non-winning entries from one Entry Period will not roll into subsequent Entry Periods, if any.** All potential winners are subject to verification. Each Entry Period winner, once verified by Sponsor as set forth below will be referred to herein as a “Weekly Winner.”
- On or about September 15, 2021, Sponsor will randomly select one potential Grand Prize winner from all qualified entries submitted during the Sweepstakes Period. Odds of winning the grand prize depend on the number of eligible entries received during the Sweepstakes Period. Potential winner is subject to verification. The grand prize winner, once verified by Sponsor as set forth below will be referred to herein as a “Grand Prize Winner.”

Weekly Winners and Grand Prize Winners shall be collectively referred to herein as “Winner(s).”

Each potential weekly winner and each potential grand prize winner will be **notified within five (5) days** after the applicable drawing via email and/or telephone provided during registration. Potential winners must meet all eligibility requirements, including timely replying to the notification and execution and return of all releases and documents (if any) required by Sponsor, which will include a winner affidavit form due to Sponsor within seven (7) days after winner receives notice from Sponsor of such prize. Weekly Entry Period Prizes. For each Weekly Entry Period, one (1) Weekly Winner (for a total of five (5) total Weekly Winners for the entire Sweepstakes) will receive a collegiate prize pack corresponding to the Entry Period in which they were selected as a winner (each of which has an approximate retail value (“ARV”) as set forth below). Grand Prize. One (1) Grand Prize Winner will receive a three-day/two-night trip for the Grand Prize Winner and one (1) guest (guest must be at least the age of majority in their state of residence) to the 2022 College Football Playoff National Championship game in Indianapolis, Indiana (currently scheduled for January 10, 2022) (“CFP National Championship”) (“grand prize” or “Grand Prize”). The Grand Prize will include:

(i) Round-trip, coach-class airline ticket for the winner and one (1) guest from the major U.S. gateway airport nearest to Grand Prize Winner's residence (in the 48 contiguous U.S.) to Indianapolis, IN (all as determined in Sponsor's sole discretion) (if a Grand Prize Winner resides within 250 miles of Indianapolis, Indiana ground transportation may be provided in lieu of air transportation and no compensation or substitution will be provided for difference in prize value);

(ii) One (1) hotel room, double occupancy, at a Indianapolis-area hotel (to be determined by Sponsor in its discretion), for two (2) nights, for Grand Prize Winner and guest; and

(iii) Two (2) tickets to the CFP National Championship. Grand Prize Winners and guests must comply with all rules and regulations of BCS Properties, LLC d/b/a College Football Playoff, Lucas Oil Stadium, and Sponsor.

*Additional Details for Grand Prize:*

ARV of Grand Prize: \$ 4,750. Actual value of trip may vary based on point of departure and airfare fluctuations. Any difference between stated ARV and actual value of prize will not be awarded.

All trip/travel arrangements (including, without limitation, selection of the airline, departure and arrival airport, and lodging) are determined by Sponsor in its sole discretion. Trip must be booked at least thirty (30) days in advance of CFP National Championship and travel arrangements are subject to availability. All travel must be completed by December 10, 2021. **Grand Prize Winner must be available to travel on the dates specified by Sponsor (currently January 9, 2022 until January 1, 2022; no alternate travel dates are available.** In the event the winner cannot travel to Indianapolis, IN on the timeline provided, Grand Prize Winner may be disqualified and the prize will be forfeited. The Grand Prize Winner and guest must travel on the same itinerary (on dates specified by Sponsor, which may be subject to change) and are solely responsible for obtaining proper documentation (e.g., valid photo ID) prior to travel. All travel arrangements are subject to availability, blackout dates, and other restrictions. All tickets are subject to terms and conditions of their issuers. Travel must be made through Sponsor's (or its designee's) agent, on a carrier of Sponsor's choice, in seat locations determined by Sponsor.

Winner is responsible for all costs and expenses not expressly provided for above, including, without limitation, all ground transportation, meals and beverages, travel upgrades, baggage fees, incidentals, gratuities, in-room charges (telephone calls, mini-bar, room service, movies, etc.), souvenirs, additional hotel charges and fees, taxes, and other personal expenses incurred during the use of the prize. Location of CFP National Championship ticket seats shall be selected by Sponsor in its sole discretion.

Because COVID-19 is a novel virus, Grand Prize Winner agrees and acknowledges that there is always a risk with travel and Sponsor shall not be responsible for any such risk or outcome. Further, Sponsor is not responsible for any change or difference in the availability of any amenities, offerings, or otherwise when such arises out of our effort to adhere to changes in regulations and protocols with respect to COVID-19, over which we have no control.
